AGRICULTURAL ENGINE CHANGE NOTIFICATION

The owner or operator of a stationary diesel-fueled CI agricultural engine registered under section 93115.8(c)(1) of the Stationary Diesel Airborne Toxic Control Measure (ATCM) shall notify the District in writing no later than 14 days after any change of owner or operator, change in location, installation or commencement of an emissions control strategy, or replacement with an electric motor or non-compression ignition engine.

Please use this form to notify EKAPCD if any of the following changes are made to a registered agricultural engine located within the EKAPCD: Remove from Service, Replace with New/Different Compression Ignition (CI) engine*, Replace with Electric Motor or Non-CI engine, installation of an emission control unit, Change Location**, or Change Owner/Operator.

*Any new or non-registered engine must be registered with EKAPCD prior to its use. Please use EKAPCD form PER-08, Agricultural Diesel Engine Registration.

**This form is required for changing the location of a registered if:

- Any non-Tier 4 engine is moved to within ¹/₂ mile of a residential area, school or hospital;
- Any engine moved outside the agricultural operations area listed in the engine's registration or moved outside the District;
- Any relocation causes a registered engine to be located within 400 feet of two other registered CI engines.
