MR. BRENTON SMITH WAS APPOINTED TO THE DISTRICT HEARING BOARD AT THE AUGUST 4, 2022, BOARD MEETING AND WILL BE TAKING HIS OATH OF OFFICE FOLLOWING THE MEETING TODAY.

APCO DEFERRED TO STAFF: JEREMIAH CRAVENS, SENIOR AIR QUALITY SPECIALIST.

MR. CRAVENS ANNOUNCED THAT APPLICATIONS FOR THE UPCOMING INCENTIVES PROGRAMS WILL BE ACCEPTED ON OCTOBER 1, 2022. THE DISTRICT HAS ALLOCATED \$150,000 FOR THE DMV VOUCHER PROGRAM, WHICH PROVIDES ASSISTANCE IN THE PURCHASE OF NEW ELECTRIC VECHILES; \$150,000 FOR THE WOODSMOKE REDUCTION PROGRAM TO HELP RESIDENTS REPLACE THEIR OLDER, HIGH EMITTING WOOD- BURNING STOVES; AND \$250,000 FOR THE DMV GRANT PROGRAM, WHICH PROVIDES FUNDING FOR ELIGIBLE PROJECTS, SUCH AS ROAD PAVING, EV CHARGING STATIONS, AND EDUCATIONAL OUTREACH, AMONG OTHERS WHICH ARE LISTED ON OUR WEBSITE.
